ROLL CALL/INVOCATION

The meeting was called to order by Mayor Burke. Commissioners Considine, Kuhn, Blackburn, Brechon and Mayor Burke answered Roll Call. The Pledge of Allegiance was cited. Pastor Frank Berman, Chaplain from Heritage Square gave the Invocation.

WORK SESSION RIVER STREET DISCUSSION

Jeff Reis, Willett, Hofmann & Associates, gave a slide presentation on the River Street project. He advised this work would be in two phases, the first one being Galena Avenue to Artesian Avenue, which is projected to start in July, 2015 and be completed in September, 2015. The second phase is Artesian Avenue to Route 2, which would start in September, 2015, with a completion date in November, 2015. Commissioner Kuhn stated the engineers need a general idea of what the City wants; therefore, input is needed. Mayor Burke stated this project is a great opportunity for design and economic development along the river. He stated there is a need to highlight our ethnic diversity. Mayor Burke stated he would like to see a 7-person task force appointed to work with the engineers. He further stated he is working with IDOT to get a parcel they own located at River Street and Route 2 deeded to the City. Geoff Smith, Willett, Hofmann & Associates, advised that River Road is in the flood plain area; therefore, the amenities outside this area are what need to be looked at. Commissioner Blackburn asked about the window for bidding Phase I, and Jeff Reis advised May, 2015. Commissioner Kuhn advised that Phase II would use the federal funds we currently have allocated, which is approximately \$1 million. Commissioner Blackburn stated a long-term Master Plan for the amenities could be done further down the road on this project.

RES. #2486-14 – INTER-FUND LOAN FROM CAPITAL PROJECTS FUND TO CENTRAL BUSINESS DISTRICT TIF

Commissioner Blackburn moved that a Resolution authorizing an Inter-Fund Loan from the Capital Projects Fund to the Central Business District TIF be adopted. Discussion followed. Mayor Burke advised the City is loaning itself \$1,575,000 from the TIF to be paid back at a fixed rate. Commissioner Considine asked for an explanation of the agreement. Attorney LeSage advised when the TIF was extended to 35 years from 23 years, an agreement was implemented from the taxing bodies and a surplus was created. He advised Commissioner Considine that Finance Director Paula Meyer has this agreement and could further explain this loan to him. After no further comments, the Mayor called for the vote.
