CALL TO ORDER

The meeting was called to order by Mayor Arellano.

ROLL CALL/INVOCATION

Councilmen Venier, Marshall, Marx and Mayor Arellano answered Roll Call. The Pledge of Allegiance was cited. Rev. Kim from First United Methodist Church gave the invocation.

APPROVAL OF MINUTES

Councilman Marshall moved to approve the minutes of the Regular and Closed Session Council Meeting of Monday, June 5, 2017. Seconded by Councilman Marx. Voting Yea: Councilman Venier, Marshall, Marx, and Mayor Arellano. Voting Nay: None. **Motion carried**.

APPROVAL OF MAY 2017 YTD FININANCIAL SUMMARY

Councilman Marx moved that the year-to-date financial summary through May 31, 2017 be accepted. Seconded by Councilman Marshall. It was noted that fiscal year 2018 began May 1, 2017. Voting Yea: Councilman Venier, Marshall, Marx, and Mayor Arellano. Voting Nay: None. **Motion carried**.

APPROVAL OF TOTAL LABOR AND OUTSIDE CLAIMS

Councilman Venier moved that the total labor and outside claims in the amount of \$192,773.19 be approved and ordered paid. Seconded by Councilman Marx. Councilman Venier asked if the \$10,000 was taken from the band fund. Finance Director Paula Meyer stated it came from general funds. Voting Yea: Councilman Venier, Marshall, Marx, and Mayor Arellano. Voting Nay: None. **Motion carried**.

DEPARTMENT REPORTS

Chief Langloss said that he attended the State of Illinois' Mental Health Committee hearing which met today in Dixon. He testified about Dixon's programs and the community approach. This is the first of many hearings which will help with treatment, solutions, and funding. Chief Langloss also mentioned that Officer Brauman retired recently after working 20 years for the City.

Finance Director Paula Meyer said that the City received a letter from IDOT stating that the state will not be paying the City for projects since there is not a state budget. This will impact MFT funds, funds for maintaining state roads, funds for traffic signals and

possibly gambling funds. She mentioned that last time this happened the City did receive all funds owed to them at a later time. She is working on receiving payment for the Galena Bridge railing project and the Courthouse retaining wall project since these agreements were signed well before July 1, 2017.

CITY MANAGER REPORT

City Manager O'Donnell went through the timeline of the goal making session which will involve staff and Council Members. He also mentioned that the Staff Retreat is August 18th and may be held at Sauk Valley Community College. He also stated that the boat docks are in, staff is working on removing trees in the rip rap area, an IMRF audit is taking place, the annual audit will take place the week of July 10, a full time position will be posted shortly, reasonable suspicion training is being held, and Staff is working with ShopKo property owners in regards to the installation of sidewalks.

COUNCIL REPORTS

Mayor Arellano – Thanked Officer Brauman for his years of service with the City. He also thanked the crew who put in the boat docks. He mentioned that the City has some projects that will be completed by volunteers during the United Way Day of Caring. The DIMCO property has been inspected and the City is awaiting the reports.

Councilman Venier – Thanked Matt Moeller and Matt Huyett for putting in an AC unit for a citizen in need. He mentioned that the festival this past weekend went well. The festival raises funds to put the petunia baskets around town. He also asked the Council to consider thank you for visiting signage.

Councilman Marshall – Said he is looking forward to the Petunia Festival and thanked everyone who is involved in the planning of the festival.

Councilman Marx – He was very impressed that the Substance Abuse Committee. He also mentioned that he attended the City's insurance committee and appreciated the engagement and enthusiasm of the members.

MOU WITH WILLETT HOFFMAN IN REGARDS TO RIVER ST AND RIVER RD WATER MAIN PROJECTS
