Councilman Marshall moved to approve the ordinance amending Ordinance #2984 and Lee Ogle Enterprise Zone descriptions for recording. Seconded by Councilman Marx. Andy Shaw sated the State Department of Commerce wanted a better legal description causing the ordinance to be amended. Voting Yea: Councilman Marshall, Marx, Venier, Considine, and Mayor Arellano. Mentioned there is another meeting with Willet Hoffman with respect to the City Hall remodel. Shared that he was a keynote speaker at the PARI Conference.

COUNCIL REPORTS

City Manager Langloss reviewed the process, qualifications, and costs of the bids received. He reviewed differences between IML and ICMRT. He also discussed the references he received for ICMRT. Discussion ensued. Blaine Kurth, from IML, stated what they could do for the City. Councilman Marshall moved to approve a contract between the City of Dixon and ICRMT for Liability and Compensation insurance commencing January 1, 2018. Seconded by Councilman Venier. Voting Yea: Councilman Marshall, Marx, Venier, and Considine. Voting Nay: Mayor Arellano. **Motion carried**.

ORDINANCE # 3073 – ASSISTANT CITY MANAGER

Councilman Marx moved to approve an ordinance creating the position of Assistant City Manager. Seconded by Councilman Marshall. City Manager Langloss stated this position is to identify a chain of command and could only be chosen from the Public Works Director, Fire Chief, Police chief, or Finance Director. A lengthy discussion ensued. Voting Yea: Councilman Marshall, Marx, Venier, and Considine. Voting Nay: Mayor Arellano. **Motion carried**.

ORDINANCE # 3074 – SALE OF CERTAIN PROPERTY

Councilman Considine moved to approve the sale of certain personal property, cell phones. Seconded by Councilman Venier. Voting Yea: Councilman Marshall, Marx, Venier, Considine, and Mayor Arellano. Voting Nay: None. **Motion carried**.

ORDINANCE # 3074 - DISPOSAL OF CERTAIN PROPERTY

Councilman Venier moved to approve the disposal of personal property, outdated computer equipment. Seconded by Councilman Considine. Voting Yea: Councilman Marshall, Marx, Venier, Considine, and Mayor Arellano. Voting Nay: None. **Motion carried**.

LIQUOR ESTABLISHMENTS – CHRISTMAS EVE & NEW YEAR'S EVE

Councilman Marx moved to authorize the Liquor Commission authority to grant permits at \$25 each, allowing Sunday liquor sales to any holder of Class A, B, C, or D City of Dixon liquor licenses valid only on December 24, 2017 and December 31, 2017. Seconded by Councilman Considine. Mayor Arellano stated several liquor license holders only have Monday – Saturday licenses and have requested to be open these two Sundays. Voting Yea: Councilman Marx, Considine, and Mayor Arellano. Voting Nay: Councilman Venier. Abstained: Councilman Marshall. **Motion carried**.

DIXON MUNICIPAL AIRPORT SOLAR FARM

Cenergy Power is interested in developing a solar farm at the Dixon airport. They are looking at two different 10 acre sites. Public Works Director Matt Heckman asked the Council if this was something he should pursue. Discussion ensued. The consensus of the Council was to have Staff pursue this option and bring more information back to them.

APPOINTMENT OF MUNICIPAL BAND DIRECTOR

Councilman Considine moved to approve the appointment of Mark Dempsey as Dixon Municipal Band Director for the remainder of the fiscal year ending April 30, 2018. Seconded by Councilman Venier. Voting Yea: Councilman Marshall, Marx, Venier, Considine, and Mayor Arellano. Voting Nay: None. **Motion carried**.

EXECUTIVE SESSION

Councilman Marx moved that the Special Council Meeting of Monday, December 18, 2017 meet in Executive session to consider the appointment, employment, compensation, discipline, performance or dismissal of specific employees pursuant to Section 2(c)(1) of the Open Meetings Act and to consider the purchase or lease of real estate for use by the City pursuant to Section 2(c)(5) of the Open Meetings Act. . Seconded by Councilman Marshall. Voting Yea: Councilman Marshall, Marx, Considine, Venier and Mayor Arellano. Voting Nay: None. **Motion Carried**.
