WORK SESSION – FY 19 BUDGET REVIEW

City Manager Langloss reviewed the municipal band fund and opened this up for discussion. It was noted that the band fund money can be used for any performing arts and were considering using money for the Dixon Theatre from this fund as well. Discussion ensued. The Council would like to see \$25,000 allocated for the band instead of \$20,000. They requested to see the band's budget.

Councilman Marx joined the meeting at 4:40 PM.

Discussion ensued with respect to public relations, marketing, petunias, and pensions. City Manager Langloss discussed the combination of the two utilities into one fund. Discussion ensued. The Recovery fund will have no planned disbursements for FY 19. The projects that requested these funds, will come from various other funds.
